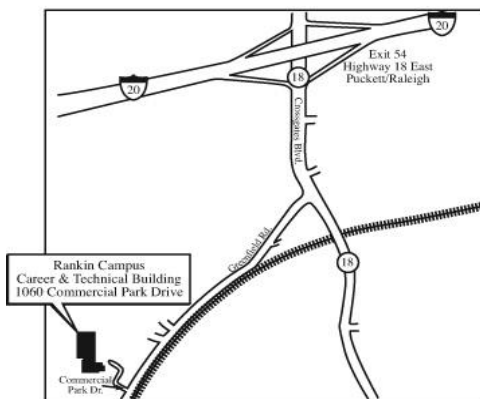
Objective
